### DESCRIPTION:

The structure is bent and then bolted from 1.5 mm and 10 mm thick steel plates. The product is made of carbon steel ASTM A36, galvanised and powder-coated according to RAL palette, or entirely of stainless steel AISI 304SS polished. The backboard is designed for 39 3/8" x 55 43/64"(B0) self-adhesive film graphics with solvent print protected by lamination. The board is double-sided.




TOP VIEW




SIDE VIEW






