
DESCRIPTION


The 3-chamber Pavo Recycling Bin 15.363.2 is a welded construction combined with wooden planks. The steel types to choose from: carbon steel galvanised and powder-coated according to RAL palette or all stainless steel ground.

Bin casing made of boards made of softwood impregnated and varnished twice or hardwood impregnated and oiled twice.

The basket is equipped with a galvanised steel container and an ashtray.
