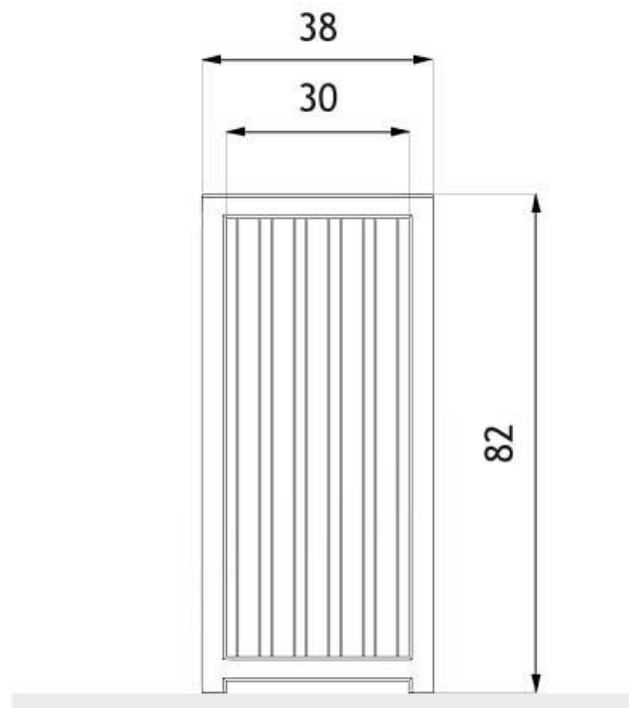

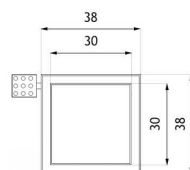
DESCRIPTION
