


# **DESCRIPTION**

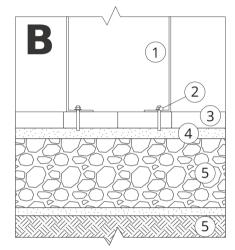

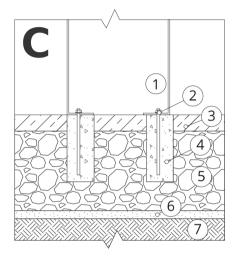

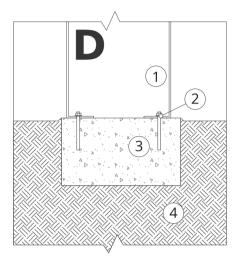
