


DESCRIPTION

IVO benches are designed in two sizes, 165 and 195 cm long. They are available in three variants: basic - without backrest, bench with backrest and armrests. The form of the bench allows you to freely create different configurations. We can arrange them linearly or create closed forms. Longer benches allow, among other things, for triangular arrangement surrounding the tree, while the inside of the three shorter benches allows you to put in a planter.
