



## **DESCRIPTION**

The Altus 12.054.4 recycling trash bin is a dual-compartment outdoor receptacle designed for sorting waste. This bin lacks internal liners and features Plexiglas walls which, when used with clear bags, allow for better visibility of the contents. This visibility is crucial for complying with certain anti-terrorism and anti-bomb regulations. The structure of the bin is crafted from steel flat bars, with options for either stainless steel or carbon steel painted in a RAL color chosen by the customer.
