### DESCRIPTION

A bench that excels in both functionality and practicality compared to other models. Its design is so versatile that it's hard to enumerate all its potential uses, given their extensive variety. This bench blends contemporary style, uniqueness, and functionality with simplicity, lightness (weighing just 55 kilograms), and easy installation, which can be done using wall anchors or as a standalone option due to its intriguing F-shaped design. The structure's notable shape is achieved by using specific flat bars and steel profiles. It is finished with pine, spruce, or optionally, exotic wood. This bench features a backrest and an armrest on one side. The separation of the seating into two parts, a larger and a smaller one, highlights its array of uses: from urban streets to shopping centers, where one might place shopping bags, to parks and residential areas where adults and children might sit separately. Its applications are as varied as one's imagination allows.

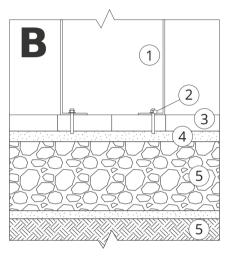


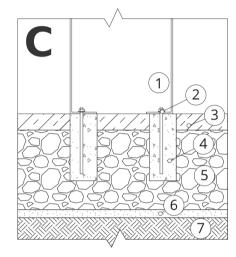


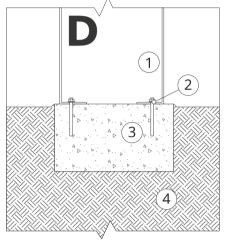
